

## Portland Natural Gas Transmission System

**President.** This position reports to the Management Committee. The President is responsible for successfully managing the direction of the Corporation. This position is a Transmission Function Employee.

**Director, Marketing and Business Development.** The individual in this position performs professional work related to marketing the Corporation's daily pipeline's services as well as long term transportation services and business development. This position is a Transmission Function Employee.

**Director, Rates and Tariffs.** This position is responsible for overseeing the department which maintains PNGTS' FERC gas tariff, files and administers PNGTS' rate proceedings, and submits related compliance filings to the FERC. This position is a Transmission Function Employee.

**Manager, Rates.** This position is responsible for the filing and administration of PNGTS's rate proceedings, the submission of related compliance filings to the FERC, and the preparation of general rate analyses associated with PNGTS and PNGTS's capital projects. This position is a Transmission Function Employee.

**Regulatory Analyst (4 positions).** This position is responsible for the preparation and support of PNGTS rate cases and related materials, and general rate analyses associated with PNGTS and PNGTS's capital projects. This position is a Transmission Function Employee.

**Manager, Tariffs & Compliance.** This position is responsible for maintaining PNGT's FERC gas tariff and submitting related compliance filings to the FERC. This position is a Transmission Function Employee.

**Regulatory Analyst (3 positions).** This position is responsible for the preparation of PNGTS's rate and tariff materials, and related compliance matters. This position is a Transmission Function Employee.

**Grad Rotational Program.** This position has duties that overlap both analyst groups noted above. This position is a Transmission Function Employee.

**Manager, Mainline Planning East** This position is responsible for planning, directing and reviewing the facility designs of the pipeline system. This position is a Transmission Function Employee.

**System Design Engineer (Level 3).** This position is responsible for developing cost effective facility sets. This position is a Transmission Function Employee.

**Director, Commercial Services.** This position is responsible for day-to-day transactions with customers and interconnecting pipelines, including nominations, contracts, credit and billing, operations planning and outage coordination. This position is a Transmission Function Employee

**Nominations/Allocations Management (transmission) (3 positions).** This position is responsible for the general coordination of transportation and exchange activities on a daily basis, including the daily nomination process, allocation of capacity, scheduling and customer interface on transportation accounts. This position provides daily supervision and guidance to the transportation scheduling workgroup. This position is a Transmission Function Employee.

**Transportation Coordinator (transmission) (22 positions).** The individuals in this position are responsible for the daily nomination process, allocation of capacity, scheduling and customer interface on transportation accounts. This position is a Transmission Function Employee.

**Volume Planners (5 positions).** The individuals in this position are responsible for the daily nomination process, determination of capacity, allocation of capacity, scheduling and customer interface on transportation accounts. This position is a Transmission Function Employee.

**Director, Operation Services.** This position is responsible for providing daily operation services activities including gas control and gas quality & measurement integrity. This position is a Transmission Function Employee.

**Manager, Gas Quality & Measurement Integrity.** This position is responsible for managing the day to day functions relating to tariff gas quality specifications and field measurement data. This position is a Transmission Function Employee.

**Gas Quality Representative.** This position is responsible for the investigation and resolution of gas quality issues. This position is a Transmission Function Employee.

**Senior Measurement Analyst.** This position is responsible for measurement data integrity analysis. This position is a Transmission Function Employee

**Engineer Grad Rotational Program.** This position is responsible for providing general Gas Quality and Measurement integrity support. This position is a Transmission Function Employee.

**Manager, Gas Control.** This position is responsible for the day to day activities of gas control, including dispatch of all pipeline flows, pipeline inventory, daily capacity, delivering/receiving scheduled gas flows, monitoring all interconnect points and meter stations for alarms and shut downs. This position is also responsible for managing the gas control response to planned and unplanned outages/events to assure safe effective and efficient operation of the pipeline. This position is a Transmission Function Employee.

**Gas Controller (14 positions).** This position is responsible for providing 24 x 7 safe, effective, and efficient remote operation, monitoring and control of the pipeline to ensure the required gas volumes, linepack, quality, and contract pressures are achieved on a daily basis in conjunction with operations planning and field operations. Monitors system hydraulics and provides recommendations as required. Respond to line upsets, unscheduled outages, alarm, and event handling. Documents and records system events. This position is a Transmission Function Employee

**Supervisor, Gas Control (2 positions).** This position is responsible for the implementation of programs, policies and procedures within the control room. This position is the primary contact and planner of gas control procedures, pipeline operational issues, emergency preparedness and general inquiries. This position is a Transmission Function Employee.

**Manager, Operations Planning.** This position is responsible for planning and directing day to day system operational analysis, the scheduling and coordination of facility outages, and the development of system operating strategies. This position is a Transmission Function Employee.

**Operations Planners (5 positions).** These positions are responsible for day to day system operational analysis, scheduling and long-term planning of facility outages and the development of system operating strategies. These positions are transmission Function Employees.

**Outage Coordinators (4 positions).** These positions are responsible for day to day system operational analysis, scheduling and coordination of facility outages and the development of system operating strategies. These positions are transmission Function Employees.

**Manager, Contracts & Billing.** This position is responsible for managing day to day functions relating to contracts, capacity release, credit evaluations, billing and customer service for transportation services. This position is a Transmission Function Employee.

**Supervisor, Contracts & Billing.** This position is responsible for supervising the analysts completing the day to day functions relating to contracts, capacity release, credit

evaluations, billing and customer service for transportation services. This position is a Transmission Function Employee.

**Contract & Billing Analysts (7 positions).** This position is responsible for completing the day to day functions relating to contracts, capacity release, credit evaluations, billing and customer service for transportation services. These positions are Transmission Function Employees

**Manager, PNGTS Area.** This position provides leadership and technical and non-technical support for and management of field positions in PNGTS Operating Area. This position is a Transmission Function Employee.

**Pipeline Technician, Electronics, Instrumentation and Controls (EIC).** Responsible for providing technical and non-technical support related to operations and maintenance of the PNGTS pipeline facilities with a concentration in control and measurement equipment. This position is a Transmission Function Employee.

**Pipeline Technician, Corrosion Control (2 positions).** Responsible for providing technical and non-technical support related to operations and maintenance of the PNGTS pipeline facilities with a concentration in corrosion control equipment. This position is a Transmission Function Employee.
